This promotion is only available for Qualifying Vehicles of select Models at time of retail, purchased by an Eligible Consumer from an Authorized Arctic Cat dealership during the Program dates. Offer not available at all locations. Additional terms and conditions apply.

### **Qualifying Vehicles – What vehicles is this offer good for?**

This offer is only available for select Models, listed above, of new and unsold M 8000 snowmobiles for Model Year 2024.

For the avoidance of doubt, Eligible Consumers who placed a pre-order on a Qualifying Vehicle as part of Arctic Cat’s MY2024 Pre-Order Event are eligible to receive the 24 month “Extended Warranty” on their pre-order vehicles at their time of retail purchase.

### **“Extended Warranty” Limited Service Agreement**

When your factory limited warranty ends, the “Extended Warranty” Limited Service Agreement kicks in, providing another two years of protection. With the same coverage as the factory limited warranty, if a covered part or component fails, Arctic Cat will save you the costs to repair or replace the covered part.<sup>2</sup>
